TOWN OF RAYMOND IN THE PROVINCE OF ALBERTA

BYLAW NO. 1059-18

A Bylaw of the Town of Raymond in the Province of Alberta for the purpose of closing to public travel portions of public roadway (lane) to create title in the name of the municipality for subsequent disposal of the land through consolidation with an adjacent piece of land in accordance with Section 22 of the Municipal Government Act, Revised Statutes of Alberta 2000, Chapter M-26, as amended.

WHEREAS the land described as that portion of lane that lies between Lots 5 and 6, Block 43, Plan 2039I, and as illustrated in attached Schedule 'A', is no longer required for public travel; and

WHEREAS application has been made to Council to have the roadway closed; and

WHEREAS the Council of the Town of Raymond deems it expedient to provide for a bylaw for the purpose of closing to public travel certain roads, or portions thereof, situated in the said municipality, and thereafter creating title to same and disposing of same through consolidation with an adjacent piece of land; and

WHEREAS notice of the intention of Council to pass a bylaw has been given in accordance with Section 606 of the Municipal Government Act; and

WHEREAS Council was not petitioned for an opportunity to be heard by any person claiming to be prejudicially affected by the bylaw.

NOW THEREFORE BE IT RESOLVED that the Council of the Town of Raymond in the Province of Alberta does hereby close to public travel for the purpose of creating title to the following described roadway for consolidation with an adjacent piece of property, subject to rights of access granted by other legislation:

THAT PORTION OF LANE THAT LIES BETWEEN LOTS 5 AND 6, BLOCK 43, PLAN 2039I WITHIN SW1/4 SEC 8, TWP 6, RGE 20, W4M


