PURSUANT to sections 216.4, 606 and 692 of the Municipal Government Act, Revised Statutes of Alberta 2000, Chapter M-26, as amended, the Council of the Town of Raymond in the Province of Alberta hereby gives notice of its intention to consider Bylaw No. 1166-26, being an amendment to Land Use Bylaw No. 987-11.

THE PURPOSE of proposed **Bylaw No. 1166-26** is to **redesignate** the land described as:

Portion of Area A, Plan 2210085
Excepting Thereout the Southwest 0.1± ha
(0.25± acres)
Totaling Approximately 2.21 ha (5.45 acres)

from **Urban Reserve – UR-1 to Parks & Open Space – POS-1**, as shown on the map in Schedule 'A', attached hereto, to accommodate future parks and recreation.

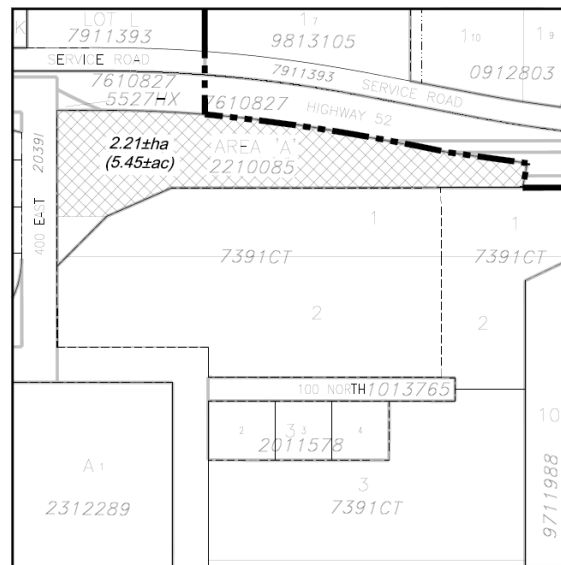
